A recent infringement was identified in the Kingdom of Morocco, where an unauthorized entity used the designation "International Union of Arab Chefs", creating confusion and public misrepresentation regarding the officially recognized institution.

Such practices constitute not only a violation of intellectual property rights, but also pose a direct risk to institutional reputation, undermine professional clarity, and compromise transparency within the culinary sector.

Institutional Actions Taken

In order to safeguard its credibility and protect its legal and professional rights, the Board of Directors of the Union has undertaken a series of formal actions, including:

- Official correspondence with relevant Moroccan authorities, formally notifying them of the infringement and requesting appropriate legal measures in accordance with applicable laws.
- Enhancing legal awareness among individuals and institutions regarding the importance of respecting intellectual property and institutional naming rights.
- Ongoing legal follow-up, in coordination with specialized legal advisors, to ensure that all procedures are executed accurately and effectively.

The Importance of Protecting Intellectual Identity

Intellectual identity is not a symbolic element; it constitutes the legal and ethical foundation upon which institutional legitimacy is built. In the case of the International Union of Arab Master Chefs, this identity reflects a firm commitment to:

- Professional quality and standards
- Institutional integrity and transparency
- Responsible innovation
- Preservation and promotion of Arab culinary heritage

Accordingly, protecting this identity remains a strategic priority to ensure continuity of professional work within a regulated and credible environment.
